- Shipping agency licenses were renewed for (28) companies for virious tonnages.
- (16) licenses were canceled for nonperformance of activities for a period of 3 years.
- The adoption of (147) approvals on operation of ships and marine units (flying the Egyptian flag) in coastal transport between Egyptian ports (cabotage).

(5) In the Field of Information Technology

- Updating the Automated Identification System (AIS) in the port authorities ,civil and military agencies, responsible for tracking ships.
- launching the electronic archive of the Maritime Transport Sector.
- Registries in the Maritime Transport Sector database reached nearly 45 million record.

(6) In the field of International Cooperation

With foreign countries and international organizations:

- Finalizing negotiations and reaching to a final version of the bilateral agreement in the field of maritime transport between the Arab Republic of Egypt and the Council of Ministers of the Republic of Albania (the agreement is ready for signature at the level of presidency).
- Enhancing the cooperation with the Italian Republic through convening a broad expert virtual meeting from both the Egyptian and Italian sides in July 2020 to discuss the operation of the RoRo line to export perishable agricultural commodities to the Italian Republic.
- Organizing the meeting of experts from the two sides which was held in Cairo on Thursday the 3rd of December 2020 to follow up the projects, agreed upon during the second Egyptian-Italian dialogue and to form a joint working group.
- During the Covid-19 outbreak crisis, all necessary coordinations were carried out with all local concerned authorities (ports and shipping agencies) together with International Transport Federation and the IMO Seamen's Crisis Task Force (SCAT) in order to contain the crisis through many measures such as unloading the ship tonnage, providing the seamen with necessary supplies and medical care ,and also working towards their repatriation (4 ships were evacuated).
- Attending the International Labour Organization (ILO) meetings.



With Arab countries:

- Following —up the measures of transferring stranded people in Dhiba Port (Kingdom of Saudi Arabia) in coordination with the concerned authorities and Alkahera Company for Ferries and Maritime Transport (14624 Egyptian, and 62 Foreign people were transferred).
- Disseminating the Terms and Conditions regarding the entry of vehicles to Kingdom of Saudi Arabia during the pilgrimage seasons (Hadj and Umra) on Transport companies that operate in the Egyptian/Saudi lines: Nweiba/Aqaba-Hurghada/Dhiba Safaga/Dihba).
