General Definitions | applicable to both private and commercial Berthing Agreements:

- · All rates are quoted in USD and are inclusive of 14% VAT.
- · Berth fee is determined upon berth size or vessel size, whichever is greater.
- · Vessel size is the overall length including tilted outboards, bowsprits and swim platforms as stated on the vessel registration or measured by Marassi Marina Yacht Club.
- · Berth size is the maximum LOA of a vessel that the berth can accommodate.
- · All rates, charges and fees are subject to change at Marassi Marina Yacht Club's discretion. This also includes increases in fees made by government or municipal department charges, all of which may be charged retrospectively in the agreed period.
- Purchasing an existing private vessel in the Marina and converting it to a commercial vessel without prior approval is strictly prohibited. Any attempts in converting a vessel without prior approval will result in the Berthing Agreement being voided and immediate removal of the vessel from the Marina. Visitor berthing fees will apply for the duration of the stay.
- · Utility consumption (power and water) is metred and charged separately on a quarterly basis. Where a metre is not available on site or is faulty, Marassi Marina Yacht Club reserves the right to apply estimated consumption charges for utilities.
- · Berthing Fees and Terms and Conditions are subject to change.
- · For commercial vessels, capacity includes passengers and crew of the vessel as per its official registration.

Private Berth Holder Benefits:

- · Discount on Fitness Membership at Address Golf Resort.
- · Discounts on Spa treatments at Address Golf Resort and Al Alamein Hotel.
- · Complimentary Pool and Beach access at Address Golf Resort and Al Alamein Hotel from 1st October to 30th May.
- \cdot Daily sailing permit assistance and regular Navigational Warning updates.
- · Buggy shuttle and ice delivery services.
- · Access to a range of parking facilities.
- · 24/7 Dock Hand and Security Services.

Joining Fee:

- · A minimum joining fee of USD 1,596 is applicable for private Berthing Agreements.
- · Joining fee rates are based upon applied for location and berth size.
- · Joining fee is a one-time fee, payable at the time of joining, non-refundable and non-transferable. Benefits are only valid in line with a valid Berthing Agreement.

TERMS AND CONDITIONS

Security Deposit:

· A refundable security deposit equivalent to two (2) months of berthing fees is required for every private and commercial vessel.

Payment Terms:

- · Payment must be made in full, prior to commencement of the Berthing Agreement with one of the following options:
 - · Cash in full
- · Card in ful
- · Cheque in full
- · Online transfer in ful
- · One current dated cheque and three (3) PDCs (post dated cheques)

Post Dated Cheques:

- · Post dated cheques are applicable to both private and commercial annual Berthing Agreements.
- Post dated cheques must be written clearly and always dated on the 1st of each month due.
- · The first cheque should be dated for the current date, followed by three (3) more cheques every three (3) months after.
- · USD 75 will be charged for every cheque that is either bounced, recalled or replaced.

Early Berth Offer:

- · A 10% discount on total berthing fees is offered upon renewal in the form of the Early Berth Offer.
- ·The Early Berth Offer can be availed upon renewal and completion of the first year of the Berthing Agreement.
- · To avail the Early Berth Offer, payment must be made in full by either cash, card, cheque or online transfer.
- · No post dated cheques will be accepted to avail the Early Berth Offer.
- Payment must be received at least fifteen (15) days before the start date of the new Berthing Agreement to validate the Early Berth Offer.
- · All Berthing Agreements and relevant paperwork must be signed by the owner to validate the Early Berth Offer.
- · Berthing Agreements terminated early or transferred to another customer prior to the Berthing Agreement end date will forfeit the discounted amount at the time of settlement

Visitor Berthing:

- · All rates are quoted in USD are inclusive of 14% VAT.
- The maximum duration for visitor berthing is three (3) months, after which the annual berthing fee and joining fee will be applied, subject to berthing availability.
- · Berth bookings must be made a minimum of twenty-four (24) hours in advance of arrival and are subject to berthing availability
- · Berth size is the maximum LOA of a vessel that the berth can accommodate.
- \cdot A refundable security deposit equivalent to the total duration of the stay is required
- · Catamarans are charged at 1.5 times the standard rate.
- · A 50% discount applies on the visitor rates for vessels staying for four (4) hours or less.
- · Visitor berthing is available on a commercial visitor rate for activities utilized for commercial purposes; including yacht sales brokerage charter floating restaurants dhows and ferries
- ·. In case a visitor contract extends between summer and winter season, rates will apply according to each season rate

Slipway

- · A charge of USD 25 inclusive of 14% VAT will apply for each use of the slipway for visitors.
- · Berth Holders can use the slipway on a complimentary basis for all vessels which have a current Berthing Agreement.
- · Berth Holders can enjoy a 25% discount on use of the slipway for all vessels which do not have a current Berthing Agreement.
